Filing begins at 8:00 a.m., Tuesday, May 20, 2014 and ends at 5:00 p.m., Tuesday, June 3, 2014. Note: Filing offices will be closed May 26, 2014, in observance of Memorial Day.

Candidates may file in person or by mail. Candidates who will be absent from the state during the filing period may arrange to file, in person, prior to departure.
